

A New Jersey Nonprofit Corporation

The undersigned, for the purpose of forming a nonprofit corporation pursuant to the provisions of Title 15A of the laws of the State of New Jersey, New Jersey Revised Statutes, known as the New Jersey Nonprofit Corporation Act, does hereby execute the following Articles of Incorporation:

ONE: The name of this Corporation is: A/101 Aviation Association, Inc.

TWO: This Corporation is organized for one or more of the purposes specified in N.J.S.A. Title 15A, specifically for charitable and educational purposes, and organized exclusively for one of the exempt purposes specified in Section 501(c)(19) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code.
